
ST. LORENZO RUIZ MIDDLE SCHOOL, RED DEER CATHOLIC REGIONAL SCHOOLS

In this month's edition of Touching Base, we are featuring owner's representative: Red Deer Catholic Regional Schools. This publicly funded school board located in Central Alberta, is undertaking its fourth IPD project - St. Lorenzo Ruiz Middle School.

With a student population of 10,000, the School Division was in need of additional learning spaces at the middle school grade level. Funding was received from Alberta Education for the construction of a 700-student middle school with an area of 6,640m2. Red Deer Catholic Schools engaged the services of KTJ Consulting as project manager and owner agent and worked with Alberta Education and Alberta Infrastructure to deliver this project using IPD methodology.

The majority of team selection occurred in the midst of COVID with many of the interviews occurring virtually along with the validation, which began in January 2021. An extended validation process occurred due to COVID limitations and discussions on possible additional funding to support the increased escalation and supply chain concerns. Validation was signed off without additional funding and the team worked diligently to manage escalation and material availability.

Although some items that would have been included in the construction budget in previous projects were now carried in the owner's FF&E budget, the team managed to bring the costs down to match the owner's allowable cost. One example of this was the structural steel contractor and engineer working closely with the supplier to modify the design from an open web steel joist to avoid costly material and long delivery times. The structural team designed the floor and roof decks to overlap in the corridors, eliminating beams and providing mechanical and electrical additional space for duct coordination.

Onsite weekly work plans have been taken to the next level by using a visual component as part of the six-week look ahead. With the design phase complete and the construction phase well underway the project remains on schedule and on budget with the school set to open for students in September 2023.

IPDA member companies on this project include Group2 Architecture, Mechwave Engineering (now WSP Mechanical), AltaPro Electric, and RJC Engineers. Additional companies on the IPD Team include Red Deer Catholic Regional Schools, Clark Builders, World Class Contracting, Collins Steel, and KERR Interior Systems.
